Contract: Safe Haven Pet Resort
TERMS

1.*I understand that I am responsible for any harm caused by my dog while my dog is attending Safe Haven Pet Resort. I shall indemnify Safe Haven Pet Resort against any claims made against the corporation or losses or damages of any kind suffered by Safe Haven Pet Resort as a result of my failure to inform Safe Haven Pet Resort of any pre-existing condition the dog may have (such as illness or aggression problems.) I understand and agree that in admitting my dog to Safe Haven Pet Resort the facility has relied on my representation that my dog is in good health and has not harmed or shown aggressive or threatening behavior towards any person or any other dog.

2.*I understand and agree that Safe Haven Pet Resort will not be liable for problems, damage, or injury caused by my dog provided reasonable care and precautions are followed by Safe Haven Pet Resort staff. I understand that Safe Haven Pet Resort is fully insured. I release Safe Haven Pet Resort of any liability arising from my pet(s) attendance. I understand that the daycare is a place where animals co-mingle in groups. I understand my animal may be placed in a crate for "time outs" not to exceed twenty minutes while attending Daycare, however, overnight care or an injured animal will be for longer periods of time. I understand that when dog(s) play in group's nicks and scratches may occur. Day care staff may or may not notify me immediately. If the injury is not serious staff may feel it is ok to leave the dog till the end of the day and let me know about it when I pick up. If the injury is serious I will be notified immediately.

3.*I understand and agree that any problem or injury that develops with my dog will be treated as deemed best by Safe Haven Pet Resort. Either my veterinarian or our mobile veterinarian will be contacted in the event of a medical problem that is serious in nature. Safe Haven Pet Resort staff retains sole discretion in emergency matters, without liability, and the owner of the dog agrees to promptly pay for all medical treatments received, including transportation to an emergency veterinary facility.

4.*I understand that if my dog is left for a period of three days (after my scheduled pick up date) without contact from the owner this dog will be considered abandoned and necessary steps will be taken to turn the animal over to the proper authorities.

5. *I recognize that there are inherent risks of illness or injury when dealing with animals. Such risks include, but are not limited to, problems resulting from rough play, food scraps found outdoors and kennel cough (doggie colds).

6. *I, as the owner, agree to be solely responsible for any and all acts or behavior or my pet while in the care of Safe Haven Pet Resort. If my pet should become ill or seem to be in need of medical consideration, Safe Haven Pet Resort reserves the right to administer aid and/or to use any available veterinarian. I, the owner, shall pay any expenses so incurred.

7.*The owner also agrees to take full and financial responsibility for any damage or injury caused directly by the behavior of his/her dog towards another dog or another persons property. For the protection of your pet(s), if your pet(s) become destructive, we reserve the right to confine your pet in an enclosed carrier. I, the owner, shall pay any expenses so incurred.

8*The owner of the dog agrees to take full responsibility for taking precautions against contagious illness and parasite exposure by consulting their own veterinarian, and accepts all reasonable risks of injury incurred in normal activity.

Safe Haven Pet Resort agrees to exercise due and reasonable care and to keep the boarding premises sanitary and property enclosed. The pet is to be fed properly and regularly, and to be housed in clean, safe quarters. All pets are boarded or otherwise cared for by Safe Haven Pet Resort without liability on my part for loss or damage from disease, death, running away, theft, fire, injury to persons, other pets, or property by said pet, or other unavoidable causes, due diligence and care having been exercised.

I hereby agree to the terms of this contract, and recognize that the provisions of this contract are binding upon both parties, and that this contract contains the entire agreement between the parties. I hereby agree to the foregoing as owner of the pet and that this contract applies to any and all services provided by Safe Haven Pet Resort.

VACCINATIONS: All dogs must have current vaccinations DHLPP (Distemper, Hepatitis, Leptospirosis, Parainfluenza, Parvovirus), Rabies and Bordatella (Kennel Cough). **Bordatella: For the protection of your loved one, Safe Haven Pet Resort requires Bordatella to be administered every 6 months. If it hasn't been done in the last 6 months, it is in your dogs best interest to have the Bordatella vaccination 14 days PRIOR to your dog entering the facility.

HEALTH: All dogs must be in good health and must not have been ill with a communicable condition within the last 30 days. All dogs must be on a flea prevention program.

BEHAVIOR: All dogs must be non-aggressive and not food or toy protective. (Daycare ONLY)

DAYCARE: If you are interested in daycare, your pet is required to go through a temperament test and an application needs to be filled out prior to the temperament test. We offer discounted rates for Daycare if your pet is staying in one of our suites.

AGE: All dogs must be 4 months of age or older, unless cleared by your Veterinarian.

SEX: All dogs over the age of 6 months must be spayed or neutered (this only applies to dogs that will be attending Doggie Daycare)

FOOD: Please ensure you brought enough food, otherwise there will be a \$2 charge per meal Initials _____

CHECKOUT: 11 am, check-out's after 11:00am will be charged \$10 playtime fee. Charges DO NOT apply if you utilize our Grooming services on your pets departure date. Initials _____
